- The Licensee agrees that if entering into a "Multiple Screening" agreement, notification of exhibitions beyond the first public exhibition must be made to the Licensor by email at theearfilm@gmail.com at least one week prior to the date of exhibition. **(Initial Here)** _____
- The Licensee agrees that the Licensee shall not permit the DVD and its contents (in whole or in parts) to be uploaded in any manner onto webservers, web hosts, or video-hosting websites, duplicated, sold, lent, altered, transferred, or made available in any way to any other party not contained herein at any time or in any manner other than as provided for in this Agreement. **(Initial Here)** _____
- It is anticipated that following full execution of this Agreement and receipt of the License Fee, the DVD will be shipped to Licensee within seven (7) business days via the United States Postal Service. Notification will be sent once orders have shipped. Payment is required before sending an order. Licensee shall specify in writing any defects in the DVD within 7 days of receipt. **(Initial Here)** _____
- If applicable, licensee shall return the loaned DVD within 7 days following the screening to the address provided with the DVD copy. **(Initial Here)** _____
